- C. DISCONTINUE PAYING AN ADDITIONAL 2.5% OF THE EMPLOYEES PORTION OF THE PUBLIC SAFETY PERSONNEL RETIREMENT SYSTEM CONTRIBUTION AS OF THE FIRST PAY PERIOD IN JUNE 2011 FOR A TOTAL OF 7.65% FISCAL IMPACT: This will save the District more than \$7,000 per month. (ELLIOTT)
